

MEMBERSHIP PROMOTION - JOIN A FRIEND - WIN A TRIP

TERMS AND CONDITIONS.

1. By entering this promotion, you accept these terms and conditions. Information on how to enter and information on the prize form part of these terms and conditions. Any entry not complying with these terms and conditions is invalid.
2. Entry is open to any "Existing Member" of any affiliated Grey Power Association in New Zealand, and any "New Member" who within the promotion period is introduced to and joins a Grey Power Association, provided that both the existing and new members become financial members of any Association for the year 1/4/2010 to 31/3/2011. (Existing member is defined in condition 6). Members of the "Board" (as defined in clauses 5.1 and 4.2 (a) (i) to (vi) inclusive, of the Federation constitution), and employees of Grey Power NZ Federation Inc, are ineligible to enter this promotion.
3. The promotion commences on 1 January 2010 and closes at Noon on 15 May 2010 ("Promotion Period").
4. To enter, the existing and proposed new member shall complete their respective sections of the specifically designed "Membership Promotion-Join a Friend" entry form, as supplied in the Grey Power NZ Federation Inc, National Magazine, and available from any affiliated Grey Power Association.

Submit the completed entry form to the Association nominated by the new member, together with the Association's own membership application form and relevant fee.
5. Entry is unlimited and members can submit further entries into the promotion by introducing more new members. One entry shall be included for each new and existing membership number submitted on each entry form received.
6. "Existing Member" is a member or members (double subscription) who have been financial members of any Association for at least the subscription year 1/4/2009 to 31/3/2010 and have renewed their subscription for the year 1/4/2010 to 31/3/2011.

The "New Member", once becoming a financial member for the year 1/4/2010 to 31/3/2011, can then submit further entries into the promotion by introducing more new members, as defined in clause 5 of these conditions.
7. The Promoter reserves the right to verify the validity of entries and reserves the right to disqualify any entrant for tampering with the entry process, or for submitting an entry that is not otherwise in accordance with these terms and conditions.
8. The Promoter is not responsible for any entries that, for whatever reason, are not received by the Promoter. Illegible or incomplete entries are not valid.
